

HEALTH PROFESSIONS PRE-LICENSURE

NURSING ASSISTANT/GERIATRIC AIDE

Certified Nursing Assistants/Geriatric Aides provide basic care to patients under the direct supervision of a nurse. They are able to perform delegated duties in a hospital, doctor's office, nursing home, or assisted living facility. This training consists of classroom and laboratory competency-based modules designed to prepare the student for employment in an acute care or long-term care facility. Many home care agencies also find this certification beneficial.

This course is approved through the Maryland Board of Nursing; successful completion allows the student to apply for certification in MD as a CNA and prepares students to take the National Nurse Aide Assessment Program Exam.

The FOUR (4) courses that make up this certification are Introduction to Health & Wellness, Nursing Assistant/Geriatric Aide Classroom (parts I & II), Nursing Assistant/Geriatric Aide Clinical, and CPR. The total cost, without books or college credit, is \$1,897.00 for Allegany County residents. This includes the cost for the required BLS (Basic Life Support) CPR Certification; however, students must register for this separately by calling 301-784-5341.

Introduction to Health and Wellness (CHE321)

This course is required for Nursing Assistant/ Geriatric Aide and Pharmacy Technician CE Certificate programs. It includes curriculum goals and objectives, basic concepts needed in health care, and wellness issues for patients and the health care workers. An overview of medical ethics, professional conduct, infection control, medical terminology, communicating with patients, body mechanics, wellness, proper eating habits, principles of fitness, stress and time management, and teaching patient awareness of healthy lifestyle options to enhance recovery and their everyday life will also be discussed. To meet Nursing Assistant and Pharmacy Technician requirements, students must achieve a grade of "C" or better.

This is the SAME course offered as part of the credit Nursing Assistant Curriculum and Pharmacy Technician Programs; however, no college credit is received, nor is traditional financial aid available.

Nursing Assistant/Geriatric Aide Certification Training (CHE322 and CHE342)

This course is designed to provide students with the classroom theory and clinical skills essential in assisting nurses in delivering proper basic bedside care of patients across the life span. This program offers a broad foundation of knowledge and skills for the Certified Nursing Assistant and the Geriatric Nursing Assistant. Successful completion of the course qualifies the student to apply for Maryland certification and to sit for the National Nurse Aide Assessment examination. Graduates will be able to seek employment in a variety of health care settings. Course work emphasizes growth and development throughout the life span, basic personal care, vital signs, communication and interpersonal skills, nutrition, medical asepsis, legal and ethical responsibilities, safe and efficient work practices, and medical terminology. To successfully pass this course, students must achieve a grade of "C" or better along with meeting the academic standards of the college. Students must also demonstrate successful achievement on a standardized test assessing reading. Please see page 46 for required testing details. Instructor consent required to take this course. This is the SAME course offered as part of the credit Nursing Assistant curriculum; however, no college credit is received, nor is traditional financial aid available. PHARMACY TECHNICIAN CERTIFICATION

This course will cover knowledge areas and skills required and tested on the registry exam for the state of Maryland. Students will learn about drug classifications, generic and name brands, dosage calculations, and state and federal laws regarding working in a pharmacy. The student will work with analytical balances and compounding equipment that will prepare them for clinical application. A variety of measurement systems will be covered in the course, as the student will need to be able to apply conversions properly. To successfully pass this course, students must achieve a grade of "C" or better, along with meeting the academic standards of the college. Instructor consent required to take this course. The courses that make up this certification are Introduction to Health & Wellness, Pharmacy Technician 101 (parts I & II), Pharmacy Technician 102 Internship Lecture, Pharmacy Technician Internship clinical (parts I, II & III) and CPR. The total cost, without books, is \$2,387 for Allegany County residents. This includes the cost for the required BLS (Basic Life Support) CPR Certification; however, students must register for this separately by calling 301-784-5341. This training is approved by the Maryland Board of Pharmacy. Successful completion allows the student to apply for registration as a pharmacy technician in MD.

Introduction to Health and Wellness (CHE321)

This course is required for Pharmacy Technician and Nursing Assistant/Geriatric Aide CE **certificate programs**. It includes curriculum goals and objectives, basic concepts needed in health care, and wellness issues for patients and the health care workers. An overview of medical ethics, professional conduct, infection control, communicating with patients, body mechanics, working as a team, and other health profession concerns will be discussed. The dimensions of wellness, proper eating habits, principles of fitness, stress and time management, and teaching patient awareness of health lifestyle options to enhance recovery and their everyday life will also be discussed. To meet Nursing Assistant certification and Pharmacy Technician requirements, students must achieve a grade of "C" or better.

This is the SAME course offered as part of the credit Pharmacy Technician and Nursing Assistant Programs; however, no college credit is received, nor is traditional financial aid available. Medicine Aide Certification (CHE659/CHE660)

The purpose of this course is to prepare nursing home aides for the safe preparation (pouring), administration, and charting of non-parenteral medications. Content includes medications, their usage, dosage, and the side effects. *This course has been approved by the Maryland Board of Nursing.*

Prerequisites: Because of the serious nature of the tasks to be performed, participants are required to present evidence of having met the following criteria:

- Be currently employed in a Maryland skilled care or intermediate care facility and have at least twoyears of full-time work experience as a Certified Nursing Assistant in a licensed facility.
- Be currently employed and have at least 1-year full-time work experience as a GNA in a licensed MD facility.
- Provide written evidence of employment status from Director of Nursing and/or Administrator of employing agency and a letter from Director of nursing recommending participant for the class.
- Demonstrate successful achievement of a standardized test assessing reading and mathematical skills.
- Current completed physical exam form and a copy of employer background check, including drug screen, will be required before beginning clinical. If employer is unable to provide this documentation, a background check and drug screen must be completed. The fee for these services is NOT included in the course cost. Health care professionals face difficult ethical decisions daily, a challenge heightened by the pandemic. This day-long course aims to equip them with practical skills and knowledge for ethical decision-making. Through lectures, case studies, and discussions, participants will gain a deeper understanding of common ethical issues in health care and methods to address them.

This in person course was designed for Dental Professionals, Physical Therapists and Assistants, Psychologists, Professional Counselors, Social Workers, and Addictions Counselors.



Upon completion of this course, the learner will be able to:

- Identify and explain the key concepts, theories, and principles of health care ethics.
- Describe ethical issues that frequently arise in the health care environment.
- Apply a process of ethical decision making to clinical cases.
- · Identify common obstacles to good ethical decision-making.
- Explain how to access professional and institutional resources related to health care ethics.

Dental Pharmacology, PANDA, and Infection Control (DHR796)

Infection Control In The Era Emerging/Re-emerging Disease(s): What Dental Practitioners Need to Know presented by Louis G. DePaola, DDS, MS, FAAOM, FACD, FICD

Emerging and re-emerging diseases are a fact of life in the modern world. Preventing the spread of these new and/or changing infections in the dental office presents a continuous challenge for dental practitioners. New infection control guidelines have been and will continue to be instituted to ensure that the dental office is as safe as possible. Dental practitioners must be aware of evolving infection control guidelines to protect themselves and the patients they treat. In the last fifty years numerous infectious diseases have challenged the delivery of oral healthcare. In the 1980s-1990s: the emergence of HIV/AIDS mandated significant changes in infection control practices to ensure safe treatment of patients in the dental office. In 2020, the respiratory infection COVID-19 caused by the novel coronavirus SARS-CoV-2 rapidly circumnavigated the globe, clearly illustrating the potential for a respiratory pathogen to both spread very rapidly in the modern world and cause considerable morbidity and mortality. Just as alarming is the recent increase in vaccinepreventable diseases as well as STDs and TB. This program will provide dental providers with the latest information on the management of recent emerging diseases as well as COVID-19 in the dental office. Paramount to controlling this pandemic are the principles of respiratory hygiene and cough etiquette and enhancements in respiratory protection that may need to be implemented. Emphasis will be placed on compliance issues and how a practical, cost effective "safe workplace" can be achieved in 2024. This course fulfills CDE requirements for infection control and requirements for annual OSHA training.

Proper Pharmacologic Prescribing, Proper Medication Disposal, and Use of Narcan for Dental Practitioners presented by Dr. Charles Doring, DDS, MAGD

Drug addiction and in particular the opioid crisis has become a nationwide problem. The dental profession has an ethical duty and now legal duty to participate in obtaining solutions to this epidemic. Until recently, 15% of all opioid prescriptions filled in the Unites States were written by dentists. (1) According to data collected by the Maryland Prescription Drug Monitoring Program (PDMP) and analyzed by the University of Maryland School of Pharmacy, 1/3 of opioid prescriptions filled for 12- to 17-year-old children are written by dentists (2). Many of these prescriptions go unused to be later used for nonmedical purposes. According to results from the National Survey on Drug Use and Health, among people aged 12 or older in 2020, 3.3 percent (or 9.3 million people) misused prescription pain relievers in the past year. The percentage was highest among young adults aged 18 to 25 (4.1 percent or 1.4 million people), followed by adults aged 26 or older (3.4 percent or 7.5 million people), then by adolescents aged 12 to 17 (1.6 percent or 396,000 people). The most common source for the last pain reliever they misused was from a friend or relative in some way (i.e., being given them, buying them, or taking them without asking). The COVID-19 Pandemic played a large part in increasing Substance Abuse Disorder (SUB) and decreasing availability of SUB treatment. (3)

Child Abuse & Neglect through Dental Awareness (P.A.N.D.A) presented by Dr. Doring

P.A.N.D.A. started in Missouri in 1992 to address the lack of child abuse reporting by dental professionals even though between 65-75% of all physical abuse involves injuries to the head, neck, and mouth. This course is designed to educate dentists, dental hygienists, dental assistants and others about the problems of child abuse and neglect, domestic violence, elder abuse and neglect, and human trafficking. This newly updated course aims to teach recognition of the indicators of abuse and neglect; to inform about the legal and ethical responsibility in reporting and referring victims; and to educate these professionals on becoming knowledgeable, and how to recognize, report and refer.

ACLS (CPR-769) WHO SHOULD TAKE THIS COURSE?

Healthcare professionals who either direct or participate in the management of cardiopulmonary arrest or other cardiovascular emergencies. This includes personnel in emergency response, emergency medicine, intensive care, and critical care units such as physicians, nurses, and paramedics.

COURSE COVERS:

*Basic life support skills, including effective chest compressions, use of a bag-mask device, and use of an AED

*Recognition and early management of respiratory and cardiac arrest

*Recognition and early management of peri-arrest conditions such as symptomatic bradycardia

*Airway management

*Related pharmacology

*Management of ACS and stroke

*Effective communication as a member and leader of a resuscitation team

Successful course completion includes demonstrating skills competency in all learning stations and passing the CPR and AED skills test, bag-mask ventilation skills test, a Megacode test and a written test. Upon successful completion, students received an ACLS Provider eCard, valid for two years.

TRAINING FOR THE NON-HEALTHCARE PROFESSIONAL

The ACM Training Center is committed to a standard of excellence in the teaching and training of the general public in the fundamentals of basic CPR and First Aid. An individual's survival and subsequent recovery from a heart attack or a serious accident is often directly related to the quality of care immediately provided by a family member or person(s) on the scene. The ACM Training Center will provide the highest caliber of instruction to those individuals preparing for the time when they may be called upon to act.

Heartsaver First Aid and Adult CPR (with optional Child CPR AED and Infant CPR) (CPR101) According to the Occupational Safety and Health Administration (OSHA), approximately 4 million injuries and illnesses occur annually in the workplace, and nearly 80 percent of sudden cardiac arrests occur outside the hospital.

Heartsaver First Aid CPR AED is a classroom, video-based, instructor-led course that teaches students critical skills needed to respond to and manage a first aid, choking or sudden cardiac arrest emergency in the first few minutes until emergency medical services (EMS) arrives. In this course, students learn skills such as how to treat bleeding, sprains, broken bones, shock, and other first aid emergencies. This course also teaches adult CPR and AED use.

Upon successful completion of the course, including a first aid, CPR and AED skills test, students receive a Heartsaver First Aid CPR AED course completion card, valid for 2 years.

Audience: All lay rescuers, including childcare workers, babysitters, firefighters, police, airline personnel, security guards, or family members of patients at high risk for cardiac arrest. *This course meets OSHA standards for First Aid.*

Prerequisites: None. This course is specifically designed for the layperson, so students are not expected to know any of the material or have related experience. The registration cost includes a workbook provided during class.

TRAINING FOR HEALTHCARE PROFESSIONALS

Basic Life Support (BLS) Provider (CPR775) The Basic Life Support (BLS) Provider Course is a video-based, Instructor-led course that teaches both single-rescuer and team basic life support skills for application in both prehospital and in-facility environments, with a focus on high-quality CPR and team dynamics. This course trains participants to promptly recognize several life-threatening emergencies, give high-quality chest compressions, deliver appropriate ventilations and provide early use of an AED.

BLS Provider teaches skills using the American Heart Association's proven Practice-While-Watching technique, which allows Instructors to observe students, provide feedback and guide students' acquisition of skills.

Upon successful completion of the course, including a CPR and AED skills test and a written test, students receive a BLS Provider course completion card, valid for 2 years.

Audience: Physicians, nurses, paramedics, EMT's, respiratory, physical & occupational therapists, physician assistants, residents, medical/nursing students, aides, and other allied health personnel and lifeguards that choose to pursue this important credential for personal and/or work-related reasons.

Prerequisites: None. This course is recommended for the professional healthcare provider. The cost of registration includes the cost of the workbook which students will receive at the beginning of class.

DBT: The Basics—Four Part Training (2024-2025)

Dialectical Behavior Therapy (DBT) has gained increased recognition and popularity in recent years as the intervention has repeatedly demonstrated effectiveness in treating emotional dysregulation, impulsive behaviors, and suicidality. Originally developed to treat adults with symptoms of Borderline Personality Disorder, DBT has been adapted to help individuals with a variety of diagnoses and symptomology including eating disorders, complex mood disorders, substance use disorders, and adolescent suicidality. This four-part training will provide you with a solid introduction to DBT and will equip you with strategies you can integrate into your therapeutic practice, as appropriate, to begin offering DBT-informed care.

*If you attended the DBT trainings last year (Fall 23/Spring 24), the structure will be very similar and there will be updated case examples, didactic activities, and a stronger focus on actively practicing DBT strategies and skills during the training sessions.

DBT Parts 3 and 4 will offered in Spring 2025.

2-Day Model Facilitator Training: COC124

The Community Resilience Network has piloted a new 2-day Mind-Body self-care experimental program as noted on page 57. Individuals who have completed the Professional and Advanced Trainings in Mind-Body Medicine through CMBM are eligible to receive training in this new 2-day model. The model blends CMBM tools with other activities and techniques into a concentrated, but relaxing format.

Steps for CMBM Facilitators to offer the 2-day program:

- o Complete CMBM's Professional and Advanced Training (a prerequisite for this course)
- o Participate in a 2-Day group (Part One COC110, \$129)
- o Co-facilitate a 2-Day group with a member of the Certified CRN pilot team, (Part two)
- o Receive mentorship (similar to CMBM Supervision) when offering your first solo group. Part three, 3 sessions.)
- o Receive a recommendation from co-facilitator or Mentor to lead 2-Day groups through the Resilience Institute.

The training cost is just \$160 (plus the cost of COC110 for a total cost of \$289. Facilitator training cost includes 6 meals.) Candidates interested in pursuing this training will work with ACM to recruit participants for the co-facilitated group and ACM will schedule supervision for the first independent group. Dates for parts two and three, (the co-facilitated group and solo group mentorship) will be established after completion of COC110. Please register separately for part one. You will have two years from the start of part one to complete the three parts of the training.
