

# **FY2027 State of Maryland Budget**

As I have previously shared, Maryland budget analysts presented a FY27 budget update/projection to the State's Spending Affordability Committee. Below is the projected State of Maryland operating deficit for FY27 through FY31 (from a deficit of nearly \$1.5 billion to almost \$4 billion. Governor Moore will present his FY27 budget request in January, which will help guide our budget planning for FY27 and beyond. To ensure continued transparency and open communication, I will keep the ACM community updated throughout the legislative session on matters related to ACM and the budget.
