Enrollment

As of the end of the day yesterday, after deregistration was run, the Spring 2026 headcount is 2503, down by 2.7% and total credits are 21,164, down 3.4%. Early college is reflected. Students may still enroll in class, so I encourage everyone to help spread the word and support the enrollment process.

Registration Details:

- Students can enroll in classes (if seats are available) **through Wednesday, January 21, 2026, without signatures.**
- Beginning **Thursday, January 22, 2026**, signatures will be required for all courses being added or for new registrations for full-term courses.
- Students who are deregistered will be re-enrolled into their courses without signatures until the end of the business day on **Wednesday, January 21, 2026.**
- The deregistration process was run on **Thursday, January 15, 2026.**

Legislative and Budget Update

The 449th session of the Maryland General Assembly will convene in Annapolis from January 14 to April 13, 2026. Addressing the significant state budget deficit will likely dominate the session this year.

I want to share a few key dates related to the FY27 State budget:

- **Jan. 16:** MACC Presidents' meeting — We will review the budget, provide an initial response, and begin developing tactical and strategic talking points.
- **Jan. 26-27:** MACC Trustee Leadership Conference.
- **MACC Legislative Committee:** I participate in this weekly meeting to discuss legislation that will impact ACM and Maryland Community Colleges.

At the All-College Assembly on January 8, I shared plans for an upcoming meeting to discuss the FY27 budget. Please note that the date for this assembly has been rescheduled to one week later, January 28th.

The change is due to two important factors:

- The Governor's budget will not be released until January 21; and
- A legislative event involving members of the Board and me will take place in Annapolis on January 26–27, providing additional information related to the State's fiscal outlook.

I want to ensure that our discussion reflects the most current information. During this assembly, representatives from CBIZ (our employee benefits broker) will also be in attendance to provide an overview of our medical/Rx projections for FY27 and the possible impact on the FY27 budget.
